From I 85 North

I 85 North to 316 East and exit at 120/Duluth Highway. Turn right on 120/Duluth Highway, which becomes West Pike Street then Crogan Street (name changes to East Crogan after crossing over Jackson St.). Your destination will be at 422 East Crogan St. (just past McArthur Street). If you pass Dairy Queen, you went too far.

From Scenic Highway/124 N Take Scenic Highway/124 N to Jackson Street and turn left. Take Jackson Street and turn right on East Crogan Street (just past Atha Street) to 422 East Crogan St. If you are on Buford Drive, you passed the right turn on East Crogan St.

From Lawrenceville Highway/HW 29
